

The regular meeting of the City Council was held on September 20, 2016 at 7:00 P.M. The meeting was called to order by Mayor Julian Theriault with the following members present:

Mayor Julian Theriault asked council if there is a motion to accept or reject the minutes from the last meetings. Mike Eby had one correction on the minutes on the Fire Department section on that it is that if the fund goes below .21% not 21%. George Kirkwood motioned to accept the regular minutes as amended and presented. Heith Stidham seconded the motion. All said Aye. Motion carried and passed.

Review Ordinances - Susan Wordal is working on the Resolutions and Ordinances.

Mayor Comments- The Mayor said that the County Assessor wanted the City Office to look up all of the building permits for him. The Mayor said that he talked with the League of Towns and City and they said that it is the Assessor's job, he is supposed to go out and look at the properties for assessments, not the City's job. If they want copies of the building permits then they will be charged. The Mayor said that the City has a new snow plow. The Mayor said that he has been working with Sara Sattler on the Safety Compliance Inspection. The Mayor has been working on the list that is due by September 26th. The City Crew has to have a safety meeting monthly, have a safety policy, documentation on safety pictures, and signatures on the written minutes of the safety meeting for the Safety ACT. The Mayor said that on September 30th the street will be closed by the County Shop for hauling of dirt. The Mayor said that there is a camper over by Mathis Food Farm that is close to the corner and they are living there.

The Mayor will look up the City Ordinances on this. The Mayor said that the owners that are transferring ownership should be charged the moving in/out each time the \$50 to turn off previous owner and then the \$50 to turn on for the new owner.

Public Work's Report- John Adams will be taking classes on water distribution and will take the exam the last week of September.
